Wyoming Children's Society was founded in 1911. Our services throughout the last 112 years has evolved over time. Today, we provide an array of services, including providing support and counseling to birth parents and working with potential adoptive parents to grow their families through infant, waiting child, and international adoption.

The past year was both challenging and rewarding. Every single person and family that comes through our doors has a unique story and unique needs. We have amazing staff that provide guidance, support, and a listening ear to each and every one of our clients. Fiscal year 2022, saw an easing of COVID requirements but it also saw an increase in all expenses across the board. We continue to have amazing and generous donors that help us to serve the women, children, and families that come through our doors every day. Some of the highlights from this past year were:

- Conducted outreach and training throughout the state to better equip people to talk about the option of adoption
- Assisted 8 women with needed resources such as counseling, food, rent, utilities, and financial assistance with medical appointments and another 22 with letters, pictures, and visits with children placed in adoptive homes
- 2 infant placements
- 4 international placements
- 1 waiting child placement
- 15 home studies completed and 4 more started
- 5 post placement families

We could not do all of this without the generosity of our donors! Each dollar donated makes a big difference in the number of people we can serve each and every day!
