Hello! We are the Reinharts and we are so happy to get to share our adoption experience with you. We adopted our daughter, Everly, last year. She is fourteen months old now and adds so much sunshine to our lives. What makes our adoption experience special is not just our daughter but also her birth mom. We are so grateful that we have an open adoption and get to have Everly's birth family in our lives.

When we envisioned our perfect adoption, we knew we would ideally have an open adoption and a relationship with the birth family. Our future child was the most important consideration to us when we chose open adoption. Any fears and hesitations we may have had were nothing compared to the positive benefits open adoptions offer to adoptees. We knew research strongly indicates that open adoptions have better outcomes for the adoptees, contributing to stronger self-esteem and positive self-identity amongst other positives. As parents, we want to give our children every advantage in life we can. For our adopted child, that includes a relationship with the birth family.

We first met our daughter's birth mom, Kaitlin, at the hospital the day she had given birth. We were so nervous and of course wanted to make a good impression. Kaitlin had not yet decided if she was going to choose adoption and wanted to meet us to help her with her decision. We were so impressed with Kaitlin and despite feeling anxious, we really enjoyed getting to meet her. She was the sweetest person and obviously an amazing mom. Her dedication to her children and strength in a situation that would bring anyone to their knees was truly awe inspiring. She let us hold our daughter and we got to chat about our lives. We learned about her kids and what they did as a family and learned what was important to her in considering adoption. We discussed our approach to an open adoption. We wanted her to know we would love for her to be involved as much as she wanted and that we would never want to sever that connection. We discussed

our firm belief that too many people loving a child was not possible- and that multiple holiday celebrations just meant that much more fun. When we left after spending about an hour with her, we didn't know what Kaitlin's decision would be. We did know no matter what she chose, the little baby we got to hold was guaranteed a future with so much love.

That evening we got the call Kaitlin had chosen us to adopt. We were of course overwhelmed and grateful and just so happy. But I also couldn't stop thinking about Kaitlin. Perhaps because we have an older son and I was already a mom, I could imagine the heartbreak she was probably feeling and I imagined she was wondering if she had made the right choice. I wanted to find her and hug her and promise everything would be ok. I wanted her to know she was family now and she and her kids were permanently lodged in our hearts.

We were so excited to be able to include Kaitlin in Everly's life. We also knew we needed to let it be up to Kaitlin to decide when and if she wanted to reconnect. I am sure Kristi Roberts (our adoption coordinator) grew tired of me constantly asking if she had heard from Kaitlin. For the first 6 months the only contact with Kaitlin was the monthly letters we sent through Kristi. I tried to keep the letters from being overwhelming. I also tried to write about how we thought of her everyday when we looked at our daughter and how we were thinking of her and her kids and hoping they were well. I wrote about how much we love Everly and how amazing she is.


When Kaitlin was ready to get in touch, she reached out to Kristi and agreed to sharing her cell number. I texted her right away- we were so excited to hear from her. We made plans for a playdate at the park and we were able to spend a wonderful hour talking while our older kids ran around. Kaitlin held Everly and I took their picture. It's one of our favorite pictures and is going in a frame for Everly's room. Since then, we've met up for trunk or treating, Santa pictures, and Holi at the Children's Garden. I try to keep my eye out for community events that everyone

might enjoy as there is a large range of age in our kids. We are thankful to live in the same community so get togethers are easier. We still send monthly letters via Kristi but we also text Kaitlin on holidays and send pictures. We got to share her first birthday cake smash and pictures of her at her party. Kaitlin is always just as sweet as the first day we met. She wrote a beautiful and heartfelt letter for Everly and sent pictures for her baby book, which we will always treasure. It makes us so happy to think Everly will know her birth family, including her half siblings.

Everly will always know she is adopted and that her adoption is a happy, positive thing. Thanks to Kaitlin, she will also always know her birth mom loves her and didn't leave her and did everything she could to give her an amazing life. We are forever grateful for everything Everly's birth mom did, and continues to do, for Everly. Elizabeth "Ibby" Davis passed away on January 31, 2024, surrounded by her loving family, loyal friends, and adoring community. The void left by Ibby's passing is felt every day.

Wyoming Children's Society was so fortunate when Ibby Davis agreed to serve on the board of directors in 1993. Her leadership style and commitment to our mission helped grow the agency over the 30 years she served on the board. During her tenure, the staff and board launched international adoption programs in Russia and was responsible for over 700 Russian children being placed in their forever adoptive homes throughout the United States. She was also instrumental in our development of innovative programs serving young women faced with unplanned pregnancies.

Ibby was a dedicated and informed board member. She served as both president and vice president during her years of service providing strong leadership to fellow board members and staff. I would watch her during board meetings as she created beautiful sketches while also participating in important agency discussions. Her sense of humor was well known which ensured there was never a dull moment in our board meetings. I miss those funny voicemail messages she would often leave-just checking in to see how things were going and challenging us to always do our best work.

Ibby's talents were many. She was an accomplished artist and former teacher. Many years ago, Ibby painted a picture of three children's faces that quickly became an iconic symbol of Wyoming Children's Society. This watercolor painting of the three children graces the front of the Wyoming Children's Society office. It will forever be an important part of Wyoming Children's Society.



Rick and Ibby Davis moved to Cheyenne over 50 years ago when Rick was a physician with the United States Air Force. Their love story is truly unique. They met in kindergarten while both lived in Wyoming, Ohio! They made Cheyenne their home where they raised their two children, Katie and Stuart. Rick served the community for decades as a gifted cardiologist. Ibby continued with her art and both became involved with community non-profits serving on boards and committees. They have touched so many lives with their volunteer spirit and their philanthropy.

I am so fortunate to have two Ibby Davis original watercolor paintings! It is not unusual for me to stop and take those paintings in while thinking of Ibby. She challenged each of us to do our best, help others and make our great state of Wyoming a good place for families to grow.
